Dear Shareholders of Ecobuilt Holdings Berhad ("Ecobuilt" or the "Company")

MEASURES TO MINIMISE RISKS OF CORONAVIRUS DISEASE 2019 ("COVID-19") INFECTION

In transitioning to the endemic phase of COVID-19, the following steps will be taken for shareholders, proxies and others who will be attending the 18th AGM in order to minimize the risks of spreading the COVID-19 virus:

- 1. If you are unwell with sore throat/fever/flu/cough/shortness of breath or any symptoms of the Covid-19, will not be allowed to attend the 18th AGM. You are strongly advised to appoint a proxy or the Chairman of the meeting to attend and vote at the 18th AGM on your behalf.
- 2. All persons must practice proper hygiene including the use of hand sanitizer and must advised to wear a face mask before the entering the meeting venue.
- 3. Shareholders are advised to check the Company's website at https://eco-built.com.my and Bursa's website at www.bursamalaysia.com from time to time for any changes to the administration of the 18th AGM that may be necessitated by changes to the directives, safety and precautionary requirements and guidelines prescribed by the Government of Malaysia, the Ministry of Health, the Malaysian National Security Council, Securities Commission Malaysia and/or other relevant authorities.

Please do read and follow the procedures below to submit proxy form electronically.

ELECTRONIC LODGMENT OF PROXY FORM

The procedures to lodge your proxy form electronically via Tricor's TIIH Online website are summarised below:

Register as a user with TIIH Online	 Using your computer, please access the website at https://tiih.online. Register as a user under the "e-Services". Please refer to the tutorial guide posted on the homepage for assistance. If you are already a user with TIIH Online, you are not required to register again. 		
Proceed with submission of form of proxy	After the release of the Notice of Meeting by the Company, login with your username (i.e. email address) and password. Select the corporate event: "ECOBUILT HOLDINGS BHD 18th AGM - SUBMISSION OF PROXY FORM". Read and agree to the Terms and Conditions and confirm the Declaration. Insert your CDS account number and indicate the number of shares for your proxy(s) to vote on your behalf. Appoint your proxy/proxies and insert the required details of your proxy/proxies or appoint the Chairman as your proxy. Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide on your votes. Review and confirm your proxy(s) appointment. Print the form of proxy for your record.		
ii. Steps for Corporate or	Institutional shareholders		
Register as a User with TIIH Online	 Access TIIH Online at https://tiih.online Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects "Create Account by Representative of Corporate Holder". Complete the registration form and upload the required documents. Registration will be verified, and you will be notified by email within one (1) to two (2) working days. Proceed to activate your account with the temporary password given in the email and re-set your own password. 		
	Note: The representative of a corporate or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar if you need clarifications on the user registration.		
Proceed with submission of form of proxy	 Login to TIIH Online at https://tiih.online. Select the corporate event: "ECOBUILT HOLDINGS BHD 18th AGM – SUBMISSION OF PROXY FORM". Agree to the Terms & Conditions and Declaration. Proceed to download the file format for "Submission of Proxy Form" in accordance with the Guidance Note set therein. Prepare the file for the appointment of proxies by inserting the required data. Login to TIIH Online, select corporate event: "ECOBUILT HOLDINGS BHD 18th AGM - SUBMISSION OF PROXY FORM". Proceed to upload the duly completed proxy appointment file. Select "Submit" to complete your submission. Print the confirmation report of your submission for your record.

Bhd. to issue a General Meeting Record of Depositors as at 2 November 2022 and only a depositor whose name appears on such Record of Depositors shall be entitled to attend the said meeting.
